The BMW Tire & Wheel Protection program provides coverage in the event of damage to your tires or wheels as a result of metal, nails, glass, debris, potholes, blowouts, etc. (excluding cosmetic damage). You can choose a plan that covers your vehicle for up to 5 years.

Your Tire & Wheel Protection program includes these important features.

- Replacement of flat tire due to road hazard.
- Replacement of damaged wheel due to road hazard.
- Coverage of all costs associated with the replacement of tires and/or wheels plus labor charges including mounting, balancing, valve stems, tire disposal and taxes.
- All vehicle tires are covered as long as they have more than $\frac{2}{32}$ " of tread at the time of damage. (A \$50 per claim deductible will apply in certain states.*)
- Tires and wheels will be replaced using original equipment manufacturer (OEM) rims and OEM-approved tires and parts.
- Available on new and certified pre-owned BMW vehicles.

- Ultimate peace of mind. You no longer have to worry about unnecessary financial hardship in the event of damage due to a road hazard. We have you covered.
- Damaged tire(s) will be replaced, not plugged or patched.
- There are no maximum number of occurrences, no claim limits and no claim aggregate.
